Applicant understands and agrees that the Agreement of Advanced Ornamentals Inc. to provide plant material and to extend credit to Applicant is conditioned upon and in consideration of the following:

Applicant certifies that all credit and financial information submitted is correct and authorizes Advanced Ornamentals Inc. to investigate and obtain reports and information concerning Applicant's credit, income, and references, and to disclose such information and investigation results as may be necessary or convenient. Applicant agrees to pay Advanced Ornamentals Inc. in accordance with the following credit terms: Balance due 30 days after invoice; finance charge of 1.5% monthly on amounts due over 30 days; Annual Percentage Rate of 18%. In any action to collect indebtedness of applicant, the prevailing party shall be entitled to recover its costs, disbursements, and attorney and/or collection fees in connection with such action and any appeal or review. Should it become necessary to file suit to enforce payment, applicant and guarantor(s) agree that such suit may be brought in the County of Marion, of the State of Oregon, and that venue for any judicial or arbitration proceeding shall be exclusively in the Marion County, Oregon, Circuit Court, in Salem, Oregon. The applicant agrees to notify Company in writing of any change in the form of ownership within ten(10) days of such change.
